Did you know the meaning of these symbols?



It is a sign of compliance with the Polish national standard approved by PKN (Polish Committee for Standardization).

It informs that the entity placing the product on the market does not ensure the quality compliant with the requirements of the standard.

Since 01.01.2003 PN is a sign of the so-called voluntary, but it can be placed on top of the product only with a compatible certificate.

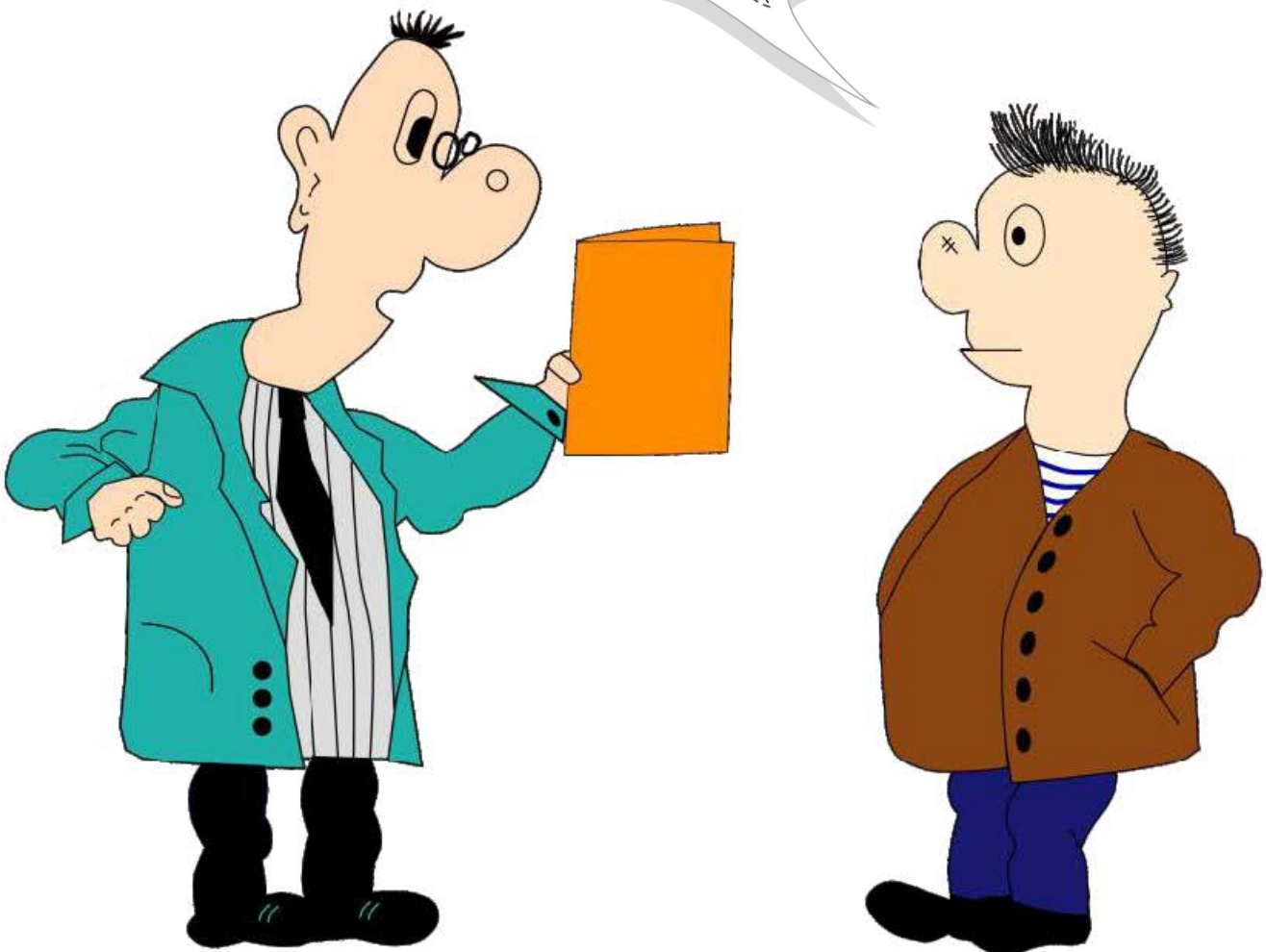

Work wear and protective clothing

Question to the expert

What is the difference between
Protective Clothing and Workwear?
How do you think?
When is CE marking required?



I will begin my answer by defining the concepts.

Work clothes

It protects or replaces the employee's own clothing in conditions of harmful factors. It is adapted to the type of work: e.g. in the hotel industry, gastronomy, health care.

Workwear is not a subject to compulsory certification, so special labeling of products is unnecessary.

Protective clothes

It replaces or covers the employee's clothing, protecting him from many risks related to the type of work performed. Wherever there is a risk of harmful substances penetrating the skin, such as:

low temperature, bacteria, viruses, fire, harmful chemicals, electricity, moisture.

This type of clothing is included in the so-called PERSONAL PROTECTION MEASURES in accordance with the Regulation of the Minister of Labor and Social Policy of September 26, 1997

Protective clothing - professional is subject to mandatory certification. This guarantees that all the requirements specified in the standards are met. It is therefore necessary to CE mark this type of clothing, as it is a special type of PERSONAL PROTECTION. Often, an instruction is also required that allows you to quickly read: the type of protective measure, the fabrics used, the maintenance description and the size of the clothing.

In the case of medical clothing, we distinguish such types as:

- anti-electrostatic,
- antibacterial,
- intended to work in operating theaters,
- barrier,
- bacteriostatic.

Already at the production stage, the above functional measures are enclosed in the fabric fibers, and only then they are specially finished and fixed so that they can provide individual protection for a specific period of use of the garment.
